## B. Sectoral Tariffs Applicable to Countries above

<b>Heavy Trucks</b>	25% (Nov 1, 2025)	Add to Reciprocal and other Tariffs	(Sec. 232): 25% effective Nov 1, 2025
<b>Pharmaceuticals (branded/patented)</b>	Up to 100%	Add to Reciprocal and other Tariffs	Announced Sept. 25, 2025, effective Oct. 1, 2025, waived if the manufacturer "is building" a U.S. plant (defined as breaking ground or under construction). Press & industry alerts pending codified HTS notes; Add on top of ALL other tariff
<b>Wood: Upholstered Furniture</b>	25% → 30% (Jan 1, 2026)	Replaces Reciprocal	Upholstered furniture (232, Sept 29): 25% (Oct 14, 2025) → 30% (Jan 1, 2026);
<b>Wood: Cabinets / Vanities</b>	25% → 50% (Jan 1, 2026)	Replaces Reciprocal	Cabinets/Vanities (232, Sept 29): 25% (Oct 14, 2025) → 50% (Jan 1, 2026)
<b>Wood: Timber / Lumber</b>	10%	Replaces Reciprocal	Lumber 10%. These replace reciprocal on covered HTS lines. EU/Japan caps 15% and UK 10% apply to wood items only.

### Key clarifications:

- "Reciprocal tariffs" are additional ad valorem under EO 14257 (Annex I) and added to MFN HTS Lines unless replaced by another instrument (e.g., wood-232).
- Transshipment penalty is 40% and applies in lieu of the reciprocal add-on. Whether it replaces other sectoral measures is uncertain.
- De Minimis: Suspended for all countries as of Aug 29, 2025 (monitor CBP for duration/updates).
- Section 232 Critical carve-out: Products tariffed under this 232 proclamation are not subject to E.O. 14257 reciprocal tariffs (i.e., no stacking of the reciprocal add-on on these items). Also, EU/Japan caps at 15% (or 10% for UK) for these wood-chain items per the proclamation.

### Formula:

Model tariff exposure as MFN (HTS Column 1) + Reciprocal + Extra Penalty Tariff (India +25%, China +20 fentanyl, etc.) + Sectoral overlays (trucks/pharma/wood) + Section 301 (for China). Apply anti-stacking rules for wood/furniture (232 duties replace reciprocal for those HTS lines).
